BY-LAW NO. 2017-36

BEING A BY-LAW TO ESTABLISH A SCHEDULE OF FEES FOR MUNICIPAL SERVICES.

WHEREAS the Municipal Act authorizes Municipalities to pass By-Laws for imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of it;


AND WHEREAS the Council for the Corporation of North Algona Wilberforce Township deems it desirable to establish a schedule of fees and charges for services or activities provided or done by or on behalf of the Municipality;

NOW THEREFORE BE IT RESOLVED THAT the schedule of fees and charges for services and activities provided or done by or on behalf of the Municipality, shall be in accordance with Schedule "A" attached hereto and forming part of this By-Law.

AND FURTHER THAT this By-Law shall come into force and take effect 18th day of July 2017.
